Applications are invited from suitable candidates for one-year Postdoctoral Research Scholarships in the College of Law and Management Studies, University of KwaZulu-Natal. The successful applicants will be expected to engage in **full-time** postdoctoral studies on an approved research program under the supervision of a member of the academic staff in one of the Schools of the College (the School of Law; the School of Commerce; or the Graduate School of Business and Leadership) as well as at the College level. Renewal for a second year is dependent on a satisfactory progress report and proof of publication in DoHET-accredited journals. Successful postdoctoral research scholars are to be based at UKZN for the duration of the scholarship.

**Minimum requirements**

- A doctoral degree relevant to the disciplines in the College of Law and Management Studies, obtained in the last five years.
- A SAQA certificate (if the doctoral degree was obtained outside South Africa).
- Research track record as evidenced by at least one peer-reviewed article in a DHET journal article. The candidate must be the first author, and the article must have been published in the last three years.
- For candidates proposing their own project, a one-page proposal is required outlining the research area and the proposed project(s) to be undertaken during the postdoctoral appointment period.

**Communication will be limited to short-listed candidates, who may be required to do a presentation at the interview.**

**The closing date for receipt of applications is Friday, 20 June 2025.**
